IPO fund raising in India halves in 2022

New Delhi, Jan 3 (IANS) Forty Indian corporates raised Rs 59,412 crore through main board IPOs in calendar year 2022, down from the Rs 1,18,723 crore (all-time high) mobilised by 63 IPOs in 2021, according to PRIME Database, India's premier database on the primary capital market.

The average deal size was a high Rs 1,485 crore. According to Haidee, as many as 17 out of the 40 IPOs, or nearly half, came in the last two months of the year, one which shows the volatile conditions prevalent through most of the year, which are not conducive for IPO activity.

Tesla falls short of 50% growth goal in 2022 amid Musk's Twitter distraction

San Francisco, Jan 3 (IANS) Elon Musk-run Tesla has missed its target of 50 per cent growth in production and deliveries in 2022, as its stock plummeted around 65 per cent amid Musk's \$44 billion Twitter takeover last year.
